1. Copy of 2024 Stevens County property tax statement.
2. Copy of current vehicle registrations for each vehicle listed on the application.
3. Check for membership fee payable to Suncrest Park Association.
4. ****Boat slips are also available for an additional fee of \$300. If interested, please include the completed Boat Slip Rental Agreement form, boat registration and a separate check for the applicable fee.**

***A copy of the Suncrest Park Regulations is available online on the Suncrest Park website at www.suncrestpark.com and should be retained by all applicants. **Additional forms can be downloaded on our website. ***Only completed applications will be processed for membership. It is the sole responsibility of the applicant to verify contents prior to submittal. Membership will email applicants outlining what's missing and the application will be set aside until complete.**

Only property owners in the Suncrest developments, as specified in the Association Bylaws Article 1, Section 2, shall be eligible for membership. Memberships are non-transferable and cannot be collectively used by others. The membership is on an annual basis from May 1st to April 30th each year. All items listed above are required for membership eligibility. Each approved applicant will receive two keys and up to two stickers, depending on the number of vehicles registered. No additional keys are available for purchase. Replacement decals and/or keys require a petition to the Park Board. Each petition will be reviewed and determined on a case by case basis.

- Membership applications and ALL accompanying documentation will only be accepted through mail services to the address listed on the application. DO NOT leave applications at the park gate or mail box outside of the park gate.
- Vehicles without properly affixed decals are NOT allowed in the park, unless pre-approved by the park board.
- Vehicles parked inside the park gates without a current membership decal will be towed at the owner's expense, as specified in the bylaws, Article 1, Section 2.
- Decals **MUST** be affixed to the outside of the vehicle windshield on the **top driver's side corner**.
