Membership Application – 2018/2019 season

March 1, 2018 – Class A Renewal Member applications accepted

April 1, 2018 – Class A NEW Member applications accepted

May 1, 2018 – Associate Member applications accepted

Each completed membership application form MUST be accompanied by:

- Copy of current vehicle registrations for each vehicle listed for application.
- Copy of current year's county property tax statement.
- Check for membership fee payable to Suncrest Park Association.
- **\*\*If applicant is NOT the property owner, the Property Owner Release form must also accompany the application. This form must also be notarized and the property resident must also include Proof of Residency.**
- **\*\*Boat slips are also available for an additional fee of \$200. If interested, please include the completed Boat Slip Rental Agreement form and a separate check for the applicable fee.**

**\*A copy of the Suncrest Park Regulations are attached to the application and should be retained by the applicant, not sent with the application.**

Only property owners and renters in the Suncrest developments, as specified in the Association Bylaws Article 1, Section 2, shall be eligible for membership. Memberships are non-transferable and cannot be collectively used by others. The membership is on an annual basis from May 1<sup>st</sup> to April 30<sup>th</sup> each year. All items listed above are required for membership eligibility. Each approved applicant will receive two keys and up to three vehicle decals (determined by vehicles listed on application, attached vehicle registration, and additional fee). No additional keys are available for purchase. Replacement decals and/or keys require a petition to the Park Board. Each petition will be reviewed and determined on a case by case basis.

- Membership applications and ALL accompanying documentation will only be accepted through mail services to the PO box listed on the application. DO NOT leave applications at the park gate or mail box outside of the park gate.
- Vehicles without properly affixed decals are NOT allowed in the park, unless pre-approved by the park board.
- Vehicles parked in the park without a current membership decal will be towed at the owner's expense, as specified in the bylaws, Article 1, Section 2.
- Decals MUST be affixed to the outside of the vehicle windshield on the **top driver's side corner**.

## CONDITIONS OF AGREEMENT

I apply for membership with Suncrest Park Association with the full acknowledgement that Suncrest Park, all bridle trails, and greenbelt areas located in Suncrest and owned by Suncrest Park Association are in various stages of primitive condition. No facilities are supervised, including but not limited to: roadways, lawns, all parking areas, swimming facilities, volleyball courts, children pay areas. As a private, unsupervised park, all members and guests of members are responsible for their own safety and behavior. Park directors and/or employees assume no duty to ensure or enforce compliance. Membership in the Association is voluntary and participation in any activities, including entrance to the park or other Association property, is with the full knowledge of the risks involved and upon signing this application, I knowingly accept all responsibility for myself, all residents of my household, and/or all persons entering Suncrest Park or any other property owned by the Association as my guest. Upon signing this application, I acknowledge I have read and understand the above language in its entirety, have been presented with and agree to abide by the Association rules. Falsifying any portion of this application is cause for membership revocation.
